

# **2022 Grant Guidelines: Advancing Equity in Education Grants**

## **ABOUT BPI**

Launched in 2007, BPI is a 100% Black-led initiative of The Winston-Salem Foundation that encourages people to collectively give their time, talent, and treasure to support a future where all Black residents in Forsyth County are thriving. We offer grantmaking and programming that supports Black communities throughout Forsyth County.

## **OUR GRANT PROGRAMS**

BPI currently offers three grant programs: **Advancing Equity in Education**, Building an Inclusive Economy, and Impact Grants. Funding for all three programs comes from the Black Philanthropy Fund, which is supported through community donations.

Our goal of advancing racial equity in education comes from the data in BPI's <u>Rethinking Philanthropy</u> report released in 2018, which reveals how systemic inequities have disproportionately affected our Black residents. BPI is a strategic initiative of The Winston-Salem Foundation, and this grant program directly aligns with the Foundation's <u>focus area</u> to advance equity in education.

## **ELIGIBILITY**

BPI wants to ensure that students of color, especially Black students, can learn in a supportive environment that respects their humanity, upholds their dignity, and has the resources to provide students with the space to learn, grow, and thrive. BPI recognizes that the pandemic has only heightened systemic inequities that continue to prevent Black students from thriving. We will support grant proposals that:

- are designed with a focus on racial equity to ensure all K-12 and higher education systems have the support they need so that every student thrives.
- are designed to make a positive impact on students of color with an explicit focus on Black students.
- are making an impact within Forsyth County, NC.
- are being implemented by a 501 (c)(3) organization, public school or higher education institution, or a faith-based organization. (Organizations that do not have a 501(c)(3) may utilize an organization with one to serve as its fiscal agent

Potential grant requests could include those that address remote learning access issues, disciplinary policies and practices that negatively impact students of color, and implicit bias training for educators.

Overall, we are looking for proposals that address systemic barriers that make it more difficult for students of color to reach their full academic potential.

## **PRIORITIES**

A *racially equitable society* is one where the distribution of resources, opportunities, and issues is not determined or predictable by race. BPI strives to support programs that address racial disparities for Black populations in Forsyth County.

Priority will be given to:

- **Black-led groups/organizations** (organizations with more than 50% of Black staff in leadership positions and/or more than 50% of board members are Black)
- Public schools with a high population of Black students
- Organizations and programs that invest directly in predominately Black schools and/or neighborhoods (including 27101, 27105, and 27107)
- Organizations/schools that are actively engaging students, parents, and/or educators in helping to guide the organization's work in education and determine its goals
- Organizations/schools that did not receive a 2021 Equity in Education grant from BPI

Why do we use Black and not African-American? We define "Black" to include the geographical and cultural traits that define Black people as people of African descent, including Africans, African-Americans, Afro-Caribbeans, Afro-Latinos, and people of mixed ancestry who identify as being Black, either alone or in combination with one or more other races.

# **FUNDING GUIDELINES**

Examples of the types of grants BPI will support:

- **Program or Project grants:** to support existing or to start new programs or projects (Funding for one-time events or for media and art projects will be considered if they are part of a larger strategy that otherwise meets the funding criteria.)
- **Planning grants:** to develop new programs or to modify existing programs to better meet the needs of the Black population in Forsyth County
- Collaboration grants: to provide funding to bring together groups in collaborative or cooperative projects that will yield greater impact than the groups would be able to achieve on their own
- Evaluation grants: to evaluate the impact on the Black community of an existing or new program that meets the funding criteria (Evaluation funding may also be included in a program or project grant request.)
- **Research grants:** to support social sciences research on educational issues that impact the Black population in Forsyth County. Requests for research funding will be considered if the research will have a direct application toward implementing a program to address the root causes of a problem or to create social change around an issue, including for advocacy purposes.
- Pilot Programs: initial small-scale projects that are used to assess the viability of program ideas

## BPI will not fund the following:

- Programs or organizations that discriminate based on ethnicity, race, color, creed, religion, national origin, gender, age, disability, marital status, sexual orientation, gender identity, or veterans' status
- Programs that proselytize or promote any particular religion or sect, or deny services to potential beneficiaries based upon religious beliefs





- Individuals, including direct scholarships
- Scholarship funds for general educational programs. Funds to support educational expenses will
  be considered if tied to the focus areas in these guidelines. This funding should be part of a larger
  program.
- Programs that focus only on providing subsidies for childcare, health insurance, housing, or any other similar services (A small portion of the project budget may be used for these items if they are part of a larger project.)
- Programs that focus only on providing direct financial assistance to meet the immediate needs of individuals (A small portion of the project budget may be used for these items if they are part of a larger project.)
- For-profit organizations
- Capital campaigns, annual campaigns or fundraising events, endowment campaigns, or retirement of debt
- Political campaigns or other partisan political activity
- Projects scheduled to be completed before the notification of funding decisions for this grant cycle

#### **GRANT AWARDS**

Organizations can submit one application for any amount up to \$15,000. BPI has discretion as to the amount awarded and may elect to make partial grants. The grant period is one year, July 2022 - July 2023.

### **APPLICATION TIMELINE**

- Monday, April 4 Application opens
- Monday, May 16 (midnight) Application deadline
- Week of June 30 Notification of funding decisions

# **HOW TO APPLY**
